AUSTIN LAKE CABIN USE AGREEMENT

This agreement constitutes a contract between the cabin guest(s) and Austin Lakes, Inc. Guest acknowledges and understands that by signing this agreement, he/she states that he/she has read and understands, will follow the written policies provided within. Guest(s) agree to leave the property in the same condition in which it was originally rented and agrees to follow all rules, verbal and printed.

- 1. CLAIMS: I agree to indemnify and hold harmless Austin Lakes, Inc., its staff, agents and employees from all claims, damages, losses, injuries and expenses arising out of or resulting from rental or usage of equipment or the facility.
- 2. RISKS: Guest understands that the campground/cabin is in a natural habitat with many obvious and hidden dangers, including but not limited to falling limbs, poison ivy, sun exposure, lake, ponds, creeks, weather, wildlife (deer, bees, wasps, hornets, spiders, snakes, raccoons, etc.) and domestic animals. Rental of and use of the campground/cabin is not risk free and there is an exhaustive list of possible injuries, trauma, accidents or even death that may occur. While it is rare and you are not likely to encounter them, they have occurred. Guest hereby releases Austin Lakes, Inc., its shareholders, management and employees for any present or future claims, including a claim for negligence, property damage, personal injury or death arising from guests' participation in this camping activity.
- 3. SECURITY DEPOSIT/PROPERTY DAMAGE CHARGES: I understand that I am responsible for this cabin and the contents. Any damages resulting during my party's stay is my responsibility as I am holding the cabin with my personal and credit card information. Additionally, it is my responsibility to know whether my cabin is pet-friendly and to know that all cabins are non-smoking. If anyone in my party chooses to bring an animal into a non pet-friendly cabin or smoke inside any cabin, I agree to pay a minimum \$100 cleaning charge per occurrence. I also understand that I am responsible for any additional damages caused by my party's smoking or its animals actions. I understand that my credit card will be charged for any cleaning fees, damages, loss of property, key fees, and inconvenience to other guests. If my credit card is declined, I will receive a bill in the mail and will have 15 days to pay.

If a credit card is not available at check-in then a deposit of \$100 cash is required. This cash deposit will be returned by check within 15 days if no damages, smoking or other loss is noted.

AUSTIN LAKE CABIN RULES

- **1. AGES:** At least one registered guest must be 21 years of age or older and will be in charge of the cabin and guests throughout the rental period.
- **2. GUEST COUNT:** The premises shall be occupied by no more than the number of people registered. **NO TENTS ARE TO BE SET UP.** Absolutely no *unregistered* overnight guests are permitted. Daily visitors must leave park by 11:00 pm.
- 3. CABIN CHECK-OUT/CHECK-IN TIME: Check-in time is 3:00 pm. Check-out time is 12:00 noon. Housekeeping needs adequate time to prepare for the next guest.
- **4. EARLY DEPARTURE/LATE ARRIVALS:** No refunds will be made for early departure or delayed arrivals. No refunds or reservation changes can be made for any reason, including inclement weather, work schedule changes, sickness, or other unforeseen issues.
- **5.** NO SMOKING: <u>All cabins are non-smoking</u>. If anyone in my party chooses to smoke in a cabin, I agree to pay a minimum \$100 cleaning charge per occurrence.
- **6. QUIET HOURS: Quiet hours are 11 pm to 8 am.** You may talk quietly after 11 pm as long as you are not disturbing any neighbors. Music must also be turned down. All children must be back on site by 11 pm.
- **7. BEHAVIOR:** Your guests are your responsibility. <u>If you cannot be sure of their behavior</u>, <u>do not include them in your plans</u>. No loud arguing, swearing or other undesirable behavior is allowed. Eviction is possible.
- **8. ALCOHOL:** Alcohol is permitted in moderation. No hard liquor. No one under 21 is permitted alcohol. This is a family oriented park and under no circumstances is alcohol to be the main focus. Recreational drugs are not welcome under any circumstances. Law enforcement could become involved.
- **9. GRILL/FIRE RING:** Each cabin is equipped with a fire ring and a charcoal grill. Firewood is available for sale or you may bring your own. Do not take firewood from other campsites.
- 10. SERVICES: At times the power goes out. Austin Lake will not be responsible for any interruption of service due to power failure or weather events. This is a naturally occurring event. In the case of interruption of water service, we will do all that is humanly possible to remedy the situation.

11. NON PET-FRIENDLY & PET-FRIENDLY CABINS:

NON PET-FRIENDLY: Swan House, Rocky Raccoon Cabin 1 & 2 and Eagle Cabin 1 & 2. If anyone in my party chooses to bring an animal into a non pet-friendly cabin, I agree to pay a minimum \$100 cleaning charge per occurrence.

PET-FRIENDLY: Train Cabin, Great Blue Heron Cabin, Keyhole Cabin 1 & 2 and Pondside Cabin 1 & 2. For your convenience, these cabins are designated pet-friendly for service dogs, seeing-eye dogs or personal pets. Please cover any furniture or bed with a sheet or blanket if pet gets on the furniture. Clean up lot and cabin thoroughly. I understand that I am responsible for any damages caused by my party's animals.

- 12. LOSS OF PERSONAL ITEMS: Each guest is solely responsible for any loss by any person, while in residence including loss of money, jewelry or other personal items. We will do our best to return items left behind at the guest's expense. Lockers are located at the Concession Stand to store items.
- 13. HOME FURNISHINGS/EQUIPMENT: Do not take any indoor furniture or chairs outside on the porch or grounds. Dishes, mugs, glassware, utensils may be used outside. Never use pots, pans, skillets, etc. over a fire. When packing up to leave, make sure whoever is packing is aware of the items that stay with the cabin. There is an inventory located in a notebook in each cabin. Loss of these items, as well as damage other than normal wear and tear will be charged to you. Do not put thumbtacks or staples in cabin woodwork.
- **14. KEYS:** Return cabin keys to the office upon your final departure. Please be sure that all doors are locked. The cost of non-returned keys is \$10 each.
- 15. CHECK-OUT: Please leave entire site clean. Wash all cooking utensils, dishes, etc. and put away. Check cabin inventory. Clean up any trash, cans, bottles, cups, food, etc. both inside and outside on the grounds. Close all windows and check entire cabin for items left behind and for any damages. Take garbage to dumpster. Recycling bins are available.

Notify main office upon your departure and return keys for final check-out. If leaving before office is open, please leave keys in the Information Mailbox at the Concession Stand.
